Provide leading dermatology education to the healthcare community supporting GPs, nurses and allied professionals to recognise and support patients by enhancing their education and access to further training.

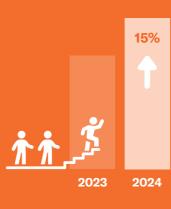
(3) Enhance Clinical Trials & Research

We collaborated with major universities and key partners, launching new research projects which were focused on new dermatology treatments and areas of interest. We expanded our clinical trials and research team to ensure we could accommodate the domestic and international interest in advancing this speciality area.

(4) Expand Registrar support and Mohs fellowship

We provided education, support and fellowship training to the largest cohort of students across Australia, ensuring that the future stars of dermatology are set for success. We continue to look at ways to enhance and expand this reach. Our registrars have a rural component to their rotations ensuring ongoing support and education into far reaching areas of NSW.

We treated over 50,000 patients in 2024, a 15% increase from 2023

Published 8 new research articles in leading dermatology journals.

Financial Highlights

Revenue

Our revenue streams are sourced as follows:

Overall revenue in 2024 increased by 13% with clinic and day surgery fees 14% higher and other income 4% higher than prior year with clinical trials and research being the key contributor.

Our 2025 revenue with a projected increase of 6% on 2024 levels is expected to exceed this current budget projection, largely due to an increase in the number of consulting doctors and doctor days, plus new research grants and increased funding for clinical trials.

The organisation has achieved some financial stability, with an overall cash positive position for the 2024 year, and are expecting this stability to continue in 2025 with renewed growth and cost saving strategies.

Investments

Patient Care	\$17,603,519 in 2024 (a 22% increase from 2023) and 2025 projected to be \$17,649,481.
Registrar Training	\$1,318,620 in 2024 and \$881,224 in 2025 (due to the change in one shared registrar position).
 Clinical trials and research 	\$766,625 in 2024 and projected \$1,164,241 in 2025 as The Skin Hospital continues to invest in this critical area.
Other Expenses	\$1,567,977 in 2024 (a 5% decrease on 2023) and 2025 projected to be \$1,838,380 (a 17% increase on 2024 which reflects new rental costs for our Westmead facility and travel costs for clinical staff to attend training events).

Stories of Change

Our commitment to patient-centred care is reflected in the feedback we have received. We conducted a satisfaction survey with our patients, and over 90% of respondents reported being satisfied with their treatment and care experience.

"I initially went to see my GP for eczema and ended up going to see a specialist doctor at The Skin Hospital.

I was really struggling with my skin condition and, after we tried every treatment, I went onto a clinical trial to see if there was something else that could work for me.

I have now been part of a clinical trial for atopic dermatitis at The Skin Hospital for around three years. For two and half years of that, I have been on a drug that cleared up my condition making it much better for me to live my life."

"I started seeing one of the specialists for my skin condition in 1979, the year I started high school. My psoriasis started off simply as what looked like dandruff, so I got some cream for that, however, it got worse and steadily progressed to all over my back and then onto my arms. By 1984, my plaque psoriasis was really impairing my quality of life and negatively affecting me.

In my opinion, The Skin Hospital has perfected the UV treatment. They go to extremes to perfect the phototherapy treatment, and they are still striving for advancements. As far as I'm concerned, they are at the leading edge of psoriasis and phototherapy, and that's a good reason to stay."

Mohs surgery, or Mohs micrographic surgery, is a specialised surgical technique used to treat certain types of skin cancer. It involves the step-by-step removal of thin layers of cancerous skin tissue, which are examined under a microscope in real time to ensure complete cancer removal while sparing as much healthy tissue as possible.

"I am thankful for the early advice I received and the time I spent listening and learning about what The Skin Hospital had to offer. Previously, I had no idea melanoma could occur in any part of the body and I am grateful to have received advice on having a Mohs procedure.

During the process, (from the reception team to the nurses and the dermatologist), the staff were helpful and caring. They were mindful about my journey. I wasn't just a patient number."

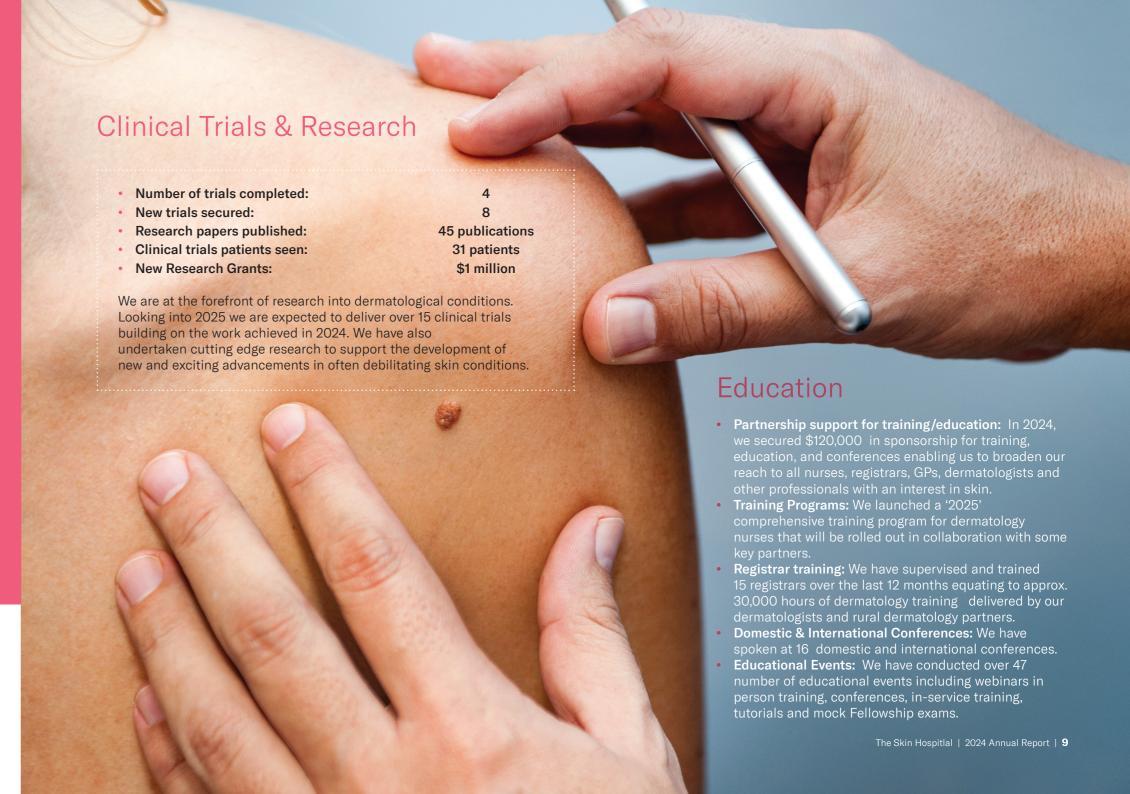

Quality and Accreditation

NSW Health conducted audits of The Skin Hospital's Westmead and Darlinghurst facilities in July 2024 and February 2025, respectively, leading to the successful renewal of both facilities' Day Surgery Licenses.

Both Day Surgery facilities are fully accredited against the National Safety and Quality in Healthcare Services (NSQHS) Standards and are actively working towards accreditation under the new Cosmetic Surgery Standards. The Clinical Trials Unit has also been assessed to the National Clinical Trials Governance Framework and is on track to transition fully to the assessment under the Australian Health Service Safety and Quality Accreditation (AHSSQA) Scheme in 2026.

The Skin Hospital routinely carries out scheduled internal infection prevention and control audits using STEAM Consulting audit tools. Additionally, both facilities underwent a successful independent audit by our external Infection Prevention and Control consultant in September 2024. These audits ensure that The Skin Hospital's policies, procedures, and practices align with the relevant standards, advisories, regulations, and legislation.

In its ongoing commitment to service improvement, The Skin Hospital benchmarks its practices against industry standards and other Day Hospitals. As part of this process, the hospital conducts reviews of incidents and clinical indicators, fire safety and infection control competencies, doctor, staff, and patient satisfaction surveys, and healthcare records audits, among others. These benchmarking activities provide valuable insights, enabling continuous enhancement of the hospital's performance.

In addition, The Skin Hospital prioritises consumer-centred care by actively engaging our patients in the planning, design, delivery, measurement, and evaluation of our systems and processes. This involvement is facilitated through our consumer representatives in day surgery, consulting, and clinical trials.

The Skin Hospital is dedicated to enhancing the quality of dermatology care by actively collaborating with the Australasian College of Dermatologists and the Australian Dermatology Nurses Association. Additionally, the hospital is a proud member of Day Hospitals Australia, the peak industry body representing the Day Hospital sector.
