Dr Frew is a dermatologist and dermatological researcher at The Ingham Institute for Applied Medical Research at the University of New South Wales in Sydney, Australia. After graduating with honours from the University of New South



Wales (UNSW), he obtained a Master of Medicine from the University of Sydney, a Master of Science from Rockefeller University in New York City and a PhD at Flinders University.


Following completion of dermatology specialist training in 2016, he undertook translational research at The Rockefeller University in New York City investigating the inflammatory mechanisms in Hidradenitis Suppurativa. Dr Frew has authored over 130 peer-reviewed articles and has a special interest in the pathogenesis and molecular mechanisms of inflammatory dermatoses. He also supervises post graduate research students and is actively involved in medical education both in Australia and globally.




• A hand eczema study for adolescents (12 - 17 years) is investigating if an experimental cream medication is an effective treatment for moderate to severe chronic hand eczema.



Participants for this trial have experienced severe hand eczema for at least three months and previous treatment with steroid cream has been unsuccessful or was not suitable.

• A plaque psoriasis study for adolescents (12 - 17 years) is exploring if Deucravacitinib is an effective treatment for plaque psoriasis. We are seeking adolescent participants who have been diagnosed with moderate to severe plaque psoriasis and are able to attend our Sydney clinic





• Finally, an Alopecia areata study for adolescents (12 - 17 years) is investigating Baricitinib in the treatment of alopecia.

Quality Improvement

 NSQHS Standard 2: Results of the Patient Satisfaction Survey

We would like to thank our patients who took the time to respond to our Annual Patient Experience Survey. The survey was conducted online and processed independently by an external benchmarking company. The high response rate of over 94% from each site reflects our patients' engagement and willingness to provide valuable feedback to improve the services we provide.

The survey was conducted across seven Patient Experience Domains including appointment and waiting times, physical access, care and treatment, information, decision making and involvement, discharge process, and patient recommendation.

Some of the major strengths identified included treating patients with respect and dignity, overall quality of the

treatment received, listening to patient's views and concerns, easy to understand and helpful information about treatment consent, and confidence in the safety of treatment and care.

Some of the opportunities for improvement identified included availability of pick up/drop off areas and disability access, inside and outside signs at the hospital, opportunity for carer/family/support person to talk to staff (if required), patient waiting times, and pre-admission preparation information. Rest assured that quality improvement initiatives are currently underway to address these feedback.

Both sites achieved high overall Australian Hospital Patient Experience Question Set (AHPEQS) scores of 96.17% at Darlinghurst and 97.62% at Westmead.

The net promoter score across both sites also remains higher than industry

benchmarks with a net promoter score of 89.23% for Darlinghurst and 88.52% for Westmead. The net promoter score is a measure of your trust and confidence, and positive word-of-mouth for The Skin Hospital.



NSQHS Standard 3: Hand Hygiene Results

Congratulations to our Westmead and Darlinghurst sites for exceeding the 86.7% national benchmark on our recent Hand Hygiene Audit at 96% and 97.5%, respectively. These outstanding results are a testament of our efforts to prevent the spread of infection and reduce the risk of healthcare-associated infection complication to our consumers.



 NSQHS Standard 8: Annual Mandatory CPR training

On 12 January 2024, The Skin Hospital welcomed the new year ready and able to respond to patient emergencies with staff from Darlinghurst and Westmead sites completing their annual mandatory CPR training.

Passed accreditation

with flying colours!

In July 2023, The Skin Hospital made history as one of the first health service organisations (HSO) within the state to undergo accreditation via mandatory short notice assessment against the National Safety and Quality Health Service (NSQHS) Standards and the National Clinical Trials Governance Framework (NCTGF).

We are pleased to report that The Skin Hospital passed with flying colours! This assessment marked the introduction

of short notice assessments which will now replace previously announced and prepared assessments. This ensures the assessment outcome accurately reflects day-to-day practice, identifies gaps, and supports HSOs to improve safety and quality systems and processes.

An onsite assessment was undertaken at both our Darlinghurst and Westmead sites to assess compliance with NSQHS standards, confirm that safety and quality systems are in place, and



examine how The Skin Hospital's quality improvement systems are used to reduce risks. The assessment involved observations, document and record reviews, and staff, patient and stakeholder interviews.

Our successful short notice assessment provides assurance to our patients that The Skin Hospital meets expected patient safety and quality standards and reaffirms our commitment to delivering the highest standard of care.


